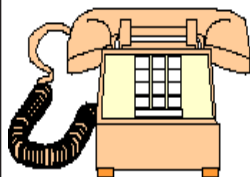

**CPT Coding for Wound Care & Debridement: Are you
coding correctly for maximized reimbursement?**

**** You should have your 2020 CPT Book!***

- These codes are defined by depth and size, not anatomic site.
- Documentation guidelines for CPT® codes 11042—11047.
- Reported by depth of tissue that is removed and surface area of wound.
- Per CPT Assistant, may be reported for injuries, infections and chronic ulcers.
- For a single wound report depth using the deepest level of tissue removed (multiple depths, one wound = one code).
- For multiple wounds of different depths, learn how to report each separately at the deepest level.

- Length x Width = Depth, but what about other characteristics of wounds to be documented for billing purposes?
