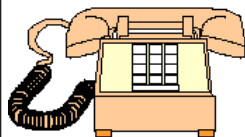

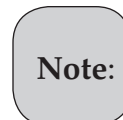

- The proposed 2021 ICD-10-CM codes include new sickle cell, substance abuse, esophagitis, GERD, hepatic fibrosis, vaping and COVID-19 diagnosis codes.
- Can Synchronous Telemedicine fit into your Practice AFTER the COVID-19 Public Health Emergency? Be prepared to post COVID-19 audits on services provided during the PHE.
- We will discuss the latest Gastroenterology ICD-10-CM and CPT updates.
- Are ALL your providers prepared for the sweeping 2021 EM changes for office and outpatient services? Use these next few months wisely to prepare!
- Full understanding of the new CMS/AMA E/M guidelines is essential to maximize reimbursement.
- Proposed 2021 payment hikes of 14-17% for office outpatient E/M services are expected.
- The blended payment rate was rescinded by CMS.
- While these changes lifting significant documentation burden are welcome news, they apply only to new and established office codes / not hospital services.
- Learn important MDM revisions and major changes to Table of Risk essential to gear up for 2021 implementation.
- Painting an accurate picture of the patient's condition and co-morbidities is essential for quality, value and outcomes reporting necessary for MACRA.
- Upper GI endoscopies are now under review for medical necessity. Will your claims pass the scrutiny?
- American Cancer Society has revised Screening Colonoscopy criteria. How is that impacting your GI practices?
- Increased MAC anesthesia denials! Do your claims demonstrate co-morbidities to support medical necessity?
- Code complex patient conditions/co-morbidity to support EM levels and MAC anesthesia.
- The importance of reporting adverse effects, poisoning, toxic effects and underdosing.
- Records that are not properly signed and dated are considered services billed but not performed.

rocedure and Other Services

- The latest Date of Service policies for Medicare and Commercial plans.
- Diagnostic studies - medical necessity and documentation guidelines.
- Pathology documentation requirements for Special Stains. Services are highly targeted!
- Separate lesions and anatomical sites are key to maximizing reimbursement for endoscopies.

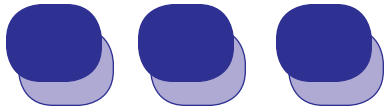
