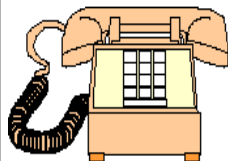

Medicare will now require your billing to provide more specific diagnosis codes than they have in past years. Does your provider's documentation support using more specific codes? Using "unspecified" diagnoses may trigger payment denials or audits."

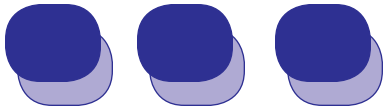
