- Telehealth continues to be covered but there are some limitations and NEW rules - what to expect.
- The CURES Act - Information Blocking rules are being enforced! Are you compliant?
- 2023 Final Proposed Rules are out. Have you commented as a Stakeholder?
- "No Surprise Act" (NSA) is now in effect for 2022. Is your practice protected?
- 2% Sequester is reinstated. Also AAP's are offsetting checks. Are you prepared?
- 2023 MPFS has published and awaiting comment. The 4% reduction in the CF is real. How will this impact overall reimbursement?

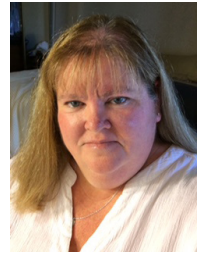
