- **Modifier Usage:** Properly utilize modifiers to indicate specific circumstances, such as multiple procedures or services performed during a single session.
- **Medical Necessity:** Learn to link procedures performed to the medical necessity of the patient's condition and the provided treatment.
- **Compliance Audits:** How to Conduct periodic compliance audits to identify any potential discrepancies and rectify them promptly.
- **Guideline Adherence:** Importance of adhering to CPT, ICD-10, and any other relevant coding guidelines to ensure accurate reporting.
- **Appeals Process:** Develop a clear appeals process to address any denied claims and resubmit with appropriate documentation if needed.
- **Utilize Technology:** Understand coding software or tools that can assist in selecting accurate codes based on the procedures performed and patient information.

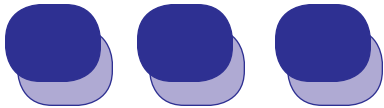
